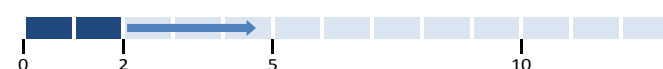

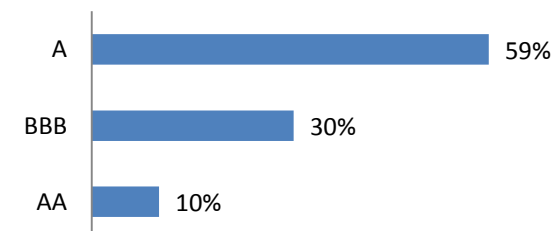
## Recommended investment horizon
